2022-2023 Independent Verification Worksheet

Federal Aid Programs

Your financial aid application has been chosen for a review process called "Verification." Verification is a process by which Tougaloo College compares the information on your application with the IRS transcripts of you and/or your spouse's 2020 tax transcript, W-2 forms, and any other financial documents. The law says that our institution has a right to ask for this information before we award you Federal aid. If there are differences in the application and the financial documents, then an electronic correction is made to your application.

What should you do for verification?

- 1. Complete and **sign** this verification worksheet.
- Return with this worksheet, a SIGNED IRS transcript of you and your spouse's (if married) 2020 tax returns.
- Submit the information to the financial aid office as soon as possible.
- Once the financial aid office has your documentation, the verification will be completed and any corrections will be made by the financial aid office.
- 5. Once verification is completed, then you can be awarded federal aid.

To obtain an IRS tax return transcript, go to www.IRS.gov and click on the "Order a Return or Account Transcript" link, or call 1-800-908-9946. Make sure to request the "IRS tax return transcript" and not the "IRS tax account transcript." For whom you are requesting the transcript for; you will need the Social Security Number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2019 IRS tax return was filed). It takes up to two weeks for IRS income information to be available for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers.
