#### Thursday, June 5, 2008

Today, I started on a new phase of the project. We received another list of churches from a colleague that contains a few more churches than our list. However, it is time to start cleaning up and verifying our list anyway. Our plan is to use phonebooks to check the addresses we retrieved from yelowpages.com. From the addresses I have looked up so far, the information in the phonebook appears to be more accurate than the information on the internet. This is shocking to us because the internet is ever changing and the phonebooks are over a year old. The spreadsheets that our colleague sent us are already split into the three counties we are working with. I am taking Hinds county, which has the most churches, for myself to verify addresses through the phonebook. I feel like this is an research project within itself! We have a task ahead of us, but we must get these surveys out as soon as possible.

### Friday, June 6, 2008

Today, I continued to verify churches in the phone book. This process is very tedious! Maybe we will be able to help others locate churches in the area when we are through with this database. I'm sure there will be plenty of other projects that need information for faith based organizations.

Today, I helped get Tonya started on the address verification with the phonebook. We discussed the issues with finding the addresses on the internet as well. I continued to work on my spreadsheet.

## Tuesday, June 10, 2008

Today I continued to work on the addresses. I also took a closer look at my survey and want to make some changes. I want to edit the first page to not be so jumbled up. The only way to do this is through HTML tags. Also, since Tonya completed her survey after I completed mine, we made changes to hers that I need to make on mine.

### Wednesday, June 11, 2008

Today we continued working on the addresses. We also wrote out what we wanted to map and find out from these surveys. This will help Dr. Fahmy when he instructs us on data analysis.

### What do we want to know?

**Evacuees Demographics** 

- 1. Race
  - A. Were more evacuees black or white?
  - B. Were more blacks given assistance?
  - C. Was there a difference in the quality of assistance?
- 2. Gender
  - A. Were more evacuees female or male?
  - B. Were more female evacuees given assistance or more males?
- 3. Education Level

- A. By gender
- B. By zip code
- C. By race

#### 4. Income Level

- A. We expect lower income evacuees were given more assistance
- B. We expect lower income evacuees to be Black
- C. We expect lower income evacuees to have low education levels

## 5. Age

- A. What were the percentages of evacuees by age?
- B. We expect a large percentage of evacuees to be children under age 12.

#### 6. Children

A. We expect a large percentage of children to be living in poverty.

### Mississippi versus Louisiana

- 1. Questions 1-4, but by state
- 2. Question 5 we expect Louisiana to have more elderly Black evacuees than Mississippi, and we expect Mississippi to have more elderly White evacuees than Louisiana.

#### Shelters

- 1. We expect more shelter to be inner-city.
- 2. We expect that the larger churches will have more shelters.
- 3. We expect that most churches did not receive government aid.
- 4. Compare the locations of churches that received funding.
- 5.

Note: For organizational survey, we can compare all data by counties.

## Migration

- 1. Distance from original location up to now.
- 2. What percentage of evacuees moved back to original area/state?
- 3. By demographics Did the elderly, low income, tend to remain in one location or move around?
- 4. Did more people from Louisiana stay in Mississippi?

### **FUTURE RESEARCH**

- 1. Survey shelters in Louisiana.
- 2. Extend survey to include all areas in Mississippi and Louisiana.

### **LIMITATIONS**

- 1. Time because it's almost three years after Hurricane Katrina.
- 2. We're only surveying the tri-county area in Jackson, Mississippi, so the results are limited.

#### Thursday, June 12, 2008

Today, we continued to look up the addresses in the phone book. I have come across some more addresses that were the same as the ones on yellopages.com, however, most of them are different. We have decided to go with the addresses in the phone book before. I think we are making a lot of progress.

## Thursday, June 19, 2008

Today, the research team met with Dr. Fahmy to discuss our surveys. We basically told him what the goals of our project were, the type of data we are looking for, and read our questions to him. Dr. Fahmy told us that our questions were valid and that we could get good data. He had us add a few questions and for some questions we added other options such as "I don't know." For questions where we had "yes" and "no" choices, we were advised to use a rating scale to give people more of a choice. This will make the data better. Dr. Fahmy said that there is really no statistical analysis or test that needs to be used for our data other than comparing numbers and doing percentages. However, he did mention that Tonya can do a Chi-squared test after her survey results are in. We will go to him for help with that

when the time comes. Dr. Fahmy also suggested that we collaborate with employees of the Jackson Heart Study to get any addresses for churches that we don't have. We feel confident that we can move forward with our survey. Next, we have deployment of the survey and collection of data.
